Update 3/3/2023 – M.U.D.'s work is progressing as planned. Some excavations will remain in the project area until the end to make final connections. Commercial customers will experience one or more temporary water shutdowns yet. If you are impacted, you will be notified ahead of time. We will soon start work in South 74th Street. See details below.

EXCAVATION (HOLE)

An excavation will soon be in South 74th Street (see below map). This work is anticipated to start the week of March 13, 2023. Duration is approximately two weeks, barring any unplanned delays. After M.U.D. work is complete, repaving will be turned over to the City of Omaha.

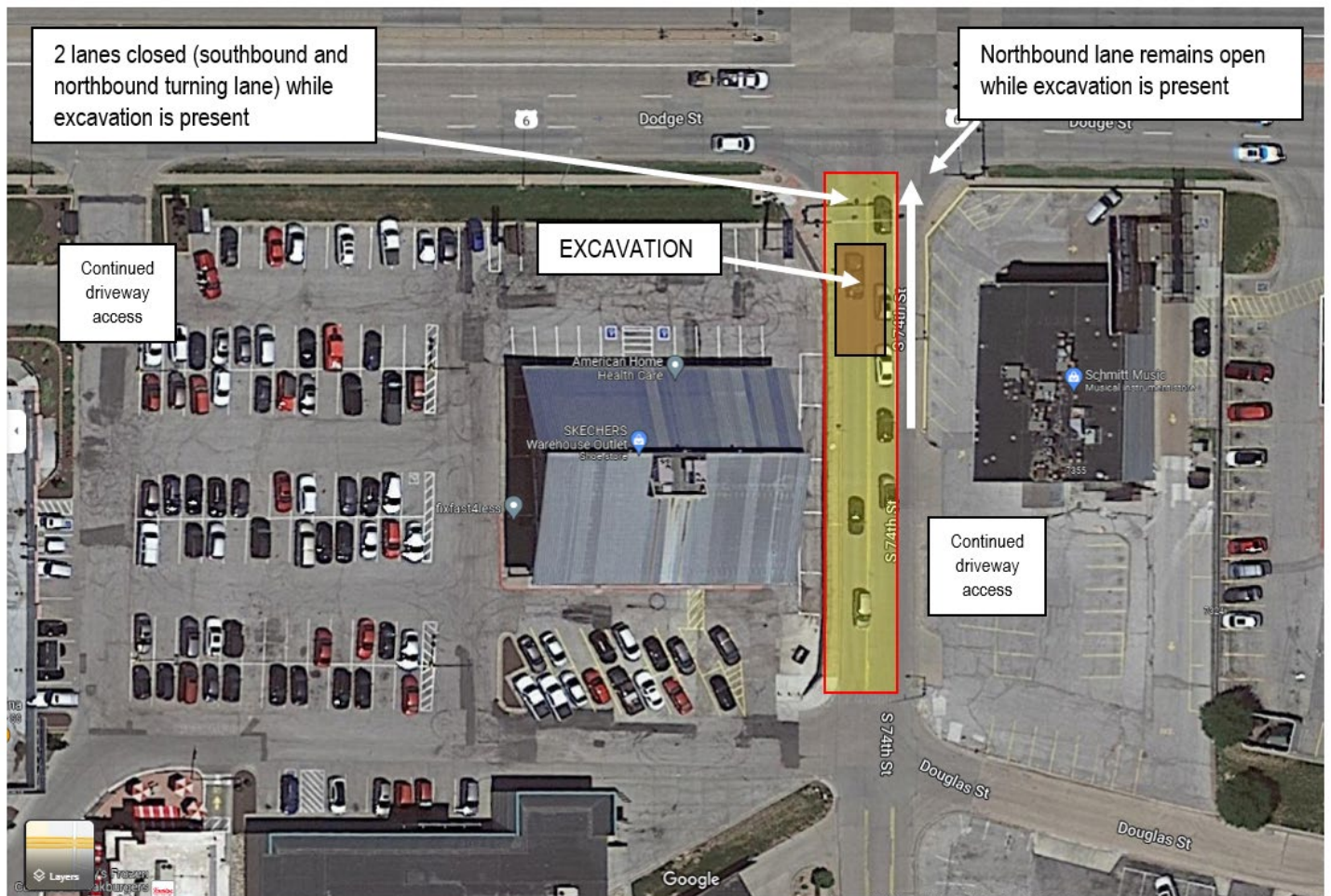
DRIVEWAY ACCESS

Commercial customers will continue to have driveway access.

TEMPORARY WATER SERVICE INTERRUPTIONS

Commercial customers may experience one (1) or more temporary water service interruptions of varying lengths in duration. Duration could be anywhere from 4 hours to 12 hours, depending on the work to be done. All will be planned and coordinated with you ahead of the scheduled dates and times, which are unknown at this time and will be determined as the work progresses. Because restaurants are impacted, these interruptions will most likely take place after hours and possibly on weekends.

WHAT

M.U.D. is required to relocate the water mains in Dodge Street from 72nd Street to 75th Avenue to eliminate conflicts with storm sewers for Dodge Street improvements for The Crossroads.

WHEN AND HOW LONG

M.U.D. anticipates starting on the west end of the project area this week, January 30 and will continue to work east. Our work is anticipated to be completed end of April 2023.

TRAFFIC

Dodge Street will have outside lane restrictions throughout the project. South 74th Street will have southbound lane restrictions. When work gets to 72nd and Dodge, the intersection will experience further restrictions.

EXCAVATIONS

Excavations will be on the north and south sides of Dodge. Some may remain throughout the project.

DRIVEWAY ACCESS

Commercial businesses will continue to have driveway access throughout the project.



Hydrants are generally in easement or Right of Way (ROW) and may be moved to accommodate the new main location and meet all fire codes.
